

- The school will provide well equipped Laboratories, Library and other facilities as per norms of the Board. The relevant books as per the academic level of students shall be made available in the library.
- 7. The School should have at least one adequately equipped computer lab with a minimum of 10 computers and would ensure computer student ratio of 1:20 at least. Proper software along with facility of Broad Band connectivity with the feature of 'internet always on' from any service provider to be ensured.
- 8. The schools affiliated and running upto Senior Secondary Level will provide suitable facilities including the equipment in laboratories/workshops and games for classes XI and XII as per requirements laid down in rules.
- 9. The school will also abide by the conditions of Recognition/NOC prescribed by the State Government concerned.
- 10. The school is required to restrict the number of sections as per the infrastructure facilities available in the school as per rule 10.6 of Affiliation Bye-laws. - The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws.
- The Board would not allow any transfer of property/sale of school by one society/ Management/ Trust to another Society/Management/Trust through agreement/sale deed. In case such transaction is effected explicitly or implicitly the Board shall withdraw its affiliation with immediate effect.

- The school shall apply for further Extension of Provisional Affiliation 'Online' through www.cbseaff.nic.in with prescribed fee and other essential documents as per the time period given by the board in this regard before the expiry of the date of provisional affiliation otherwise penalty as per rules will be charged for late execution of
- The school should not start Class IX/X/XIII (as the case may be) without written approval of the Board. The Board shall not be responsible for any consequences in case class IX/X/XIXII are started without obtaining the prior approval of the Board and without following the Affiliation Byelaws.
- It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.
